I understand and agree that this release of liability shall be construed broadly to provide a release and waiver to the maximum extent permitted by law. Unless set forth by me on this form, I know of no limitations that should prevent me from participating in any activity. I understand that this application form is a legal document and certify that the information on this form is true to the best of my knowledge. I acknowledge that such information is subject to verification and that falsification of any information shall be grounds for termination and exclusion from the membership program.
